### NB1- Resolution to Approve Preliminary Design-Build Agreement, Scope of Work and Total Cost for Preconstruction — Project #2 of Phased 10-Mile Parallel Raw Water Line Project

Executive Director Holloman advised the Design-Build evaluation team to recommend awarding the contract to Garney, Inc. and McKim and Creed. This is the next step in moving forward with design and permitting.

Motion: Director Edge MOVED; seconded by Director Zapple, to approve the Resolution to Approve Preliminary Design-Build Agreement, Scope of Work, and Total Cost for Preconstruction — Project #2 of Phased 10-Mile Parallel Raw Water Line Project. Upon voting, the MOTION CARRIED UNANIMOUSLY.

### NB2- Resolution Awarding Contract for Floor Renovation at the Kings Bluff Pump Station

Executive Director Holloman advised that the Kings Bluff Pump Station floor has experienced wear and degradation over time, creating the need for significant repairs. The Authority has solicited bids and received proposals for the renovation work, including removing the old flooring, surface preparation, and installing a durable, non-slip industrial floor coating to ensure safety and longevity. Executive Director Holloman stated that we deem the lowest responsible bidder to be \$15,912.50 from Anderson Painting and Power Washing Corporation.

**Motion**: Director Blanchard **MOVED**; seconded by Director DeVane, to approve the Resolution Awarding Contract for Floor Renovation at the Kings Bluff Pump Station. Upon voting, the **MOTION CARRIED UNANIMOUSLY**.

# **Existing Walkway Structure**

- Initially Constructed 1982
- **Timber Piles**
- Timber Decking and Handrails
- Timber Support Beams and X- Bracing

### **Project Objective**

- Evaluate various material options for the design and construction of new air backwash equipment building and elevated access walkway.
- maintenance personnel for the operation of the facilities and minimize maintenance for new structure

### Pile Options

- Precast Concrete piles
- Steel HP section piles

# Walkway Support Options

- Precast Beam
- Steel Beam

# Walkway Decking Panels Options

# Board asked McKim & Creed to provide cost estimate for options and to include timber option




## Challenges

## **Geotechnical Findings**

- Soils even worse than anticipated
- Drove Pile Depth to 35' below mudline
- Longer Piles = \$\$\$

### Walkway Height

- Design to Florence Elevation (6-7' above existing deck el.)
- Longer Piles = Bigger Equipment = \$5\$



Due to cost associated with installing the length and number of piles required, discussions with contractors and precast/steel suppliers has lead to evaluation of longer span options

# 3. Short Span Steel 12x53 H-Pile

- 18' Bridge Spans 102 Piles
- Est. \$3.9M \$4.2M

# 5. Long Span Steel w/ 24" Dia Pipe Pile

- 100' Bridge Spans 20 Piles
- Est. \$3.2M \$3.5M




